# 1. Approval of Minutes- January 23, 2023 and February 13, 2023\*

#### 2. Review of Council Financial Statements – February 2023\*

#### 4. Workforce Consortium Bylaws\*

At the request of the Executive Committee Starghill presented the amended Workforce Consortium Bylaws in their final amended format. These amendments will be transmitted to the full Council for vote at the June 12, 2023 Council meeting.

#### 5. FY2024 State Budget Update: Update and Next Steps\*

Fichtner presented an overview of the Governor's FY2024 state budget. While there is some disappointment, we need to turn our focus to strategize on our top priorities: 1.) to secure an increase of \$20 million in state operating aid for community colleges; and 2.) strengthen the position of Community Colleges by building a strong coalition that will set the groundwork for further investment in community colleges and demonstrate that community colleges are setting a direction for higher education in New Jersey.

#### 5. Report on Temporary Investments

The Council currently keeps its cash reserves in an account with Spencer Savings Bank. The Council is also enrolled in the NJ Cash Management Fund. As of February 28, 2023, the Council's NJ Cash Management Fund holdings are \$2,140,518.

# 8. ACTION: Proposed Addition of Juneteenth as a Paid Holiday for Council Staff (State Observation).

By motion of Lovell Pugh-Bassett, and seconded by David Stout, the Council approved the addition of Juneteenth to the paid holidays of the Council staff. The NJCCC Personnel Policies will be updated accordingly.

#### III. STRATEGY

## 9. Racial and Social Justice Discussion

The recent murder of Tyre Nichols has highlighted again the atrocities happening every day across our nation. The colleges are working together to try to find ways to address this injustice. Everyone's heart is in the same place on these issues and we need to find a way to move forward. Everyone agrees we cannot plod along the same. The presidents recently met and came to a consensus that more difficult conversations need to be had. One tangible thing planned is bringing the Presidents together for a facilitated full day retreat. That is tentatively scheduled to take place in early June prior to the next Council meeting. We will come back with updates at that time.

#### 10. FY2024 State Budget: Update and Next Steps

Fichtner reviewed the Governor's proposed budget with the Council membership. Fichtner reported that the Legislative Action Center has been launched. He encouraged all Council members to use the Center to email their respective legislatures to advocate for the \$20 million increase in operating aid our colleges need.

#### 11. Legislative Update

Fichtner and Nowak reviewed the legislative report in the Council packet. The Council continues to monitor the three oversight bills. Bill A4971 requires that certain information be posted on Institution's websites, including average time to degree completion. Since this metric is not a fair assessment for community colleges the Council is proposing an amendment to bill sponsors to include the language "or other appropriate measures to be determined by the Secretary of Higher Education in consultation with the impacted colleges." This amendment will give the Council an opportunity to provide input to the Secretary in the development of other appropriate measures consistent with the mission of community colleges.

#### 12. Trustee Leadership Academy

The Council in coordination with ACCT lead a successful trustee training academy in November 2022. The Council will be reaching out to the colleges to see if there is a need to host another training in June.

# 13. Modernization of the NJ Community Colleges Workforce Consortium for Economic and Workforce Development: Proposed Workforce Consortium Bylaw Amendments

Fichtner reported that the full version of proposed Consortium bylaw amendments are included in the Council packet. We ask that Council members review these amendments, which have already been approved by the Workforce Consortium's Executive Committee and Governance Board. These amendments will bring the Consortium's bylaws in line with the current mission and practices. The full Council will consider to adopt these amendments with a vote at the June 12, 2023 Council meeting. Should anyone have any questions, please feel free to reach out to Catherine Starghill.

# 1. Approval of Minutes- March 13, 2023\*

By motion of Sheetal Ranjan, and seconded by Dot Hall, the minutes of the March 13, 2023 Executive Committee meeting were approved without amendment.

#### 2. Review of Council Financial Statements – March 2023\*

By motion of Sheetal Ranjan, and seconded by Mike Gorman the March 2023 Council financials were accepted.

# • Budget Line Transfer to Meeting and Conferences

By motion of Mike Gorman, and seconded by Barbara Gaba the budget line transfer to Meetings/Conferences was approved: \$15,000 from Consultant Services and \$5,000 from Capital and Building Maintenance is transferred to Meetings/Conferences.

# 3. FY2024 State Budget: Update and Discussion of Strategy

Fichtner reported that the Senate and Assembly Budget hearings are scheduled for May 2<sup>nd</sup> and 8<sup>th</sup>. We have several presidents who have committed to coming to Trenton to represent the colleges. The Legislative Action Center has been launched. A second email to the Council membership will go out to remind them to use the center to get emails to their legislators.

#### 4. Legislative Update\*

Fichtner reported that the legislature has hit a slow down due to State Budget. We have been informed that Senator Sandra Cunningham, current chair of the Senate Higher Education Committee, is retiring. Senator Andrew Zwicker is set to potentially take her place. Longtime community college supported Assemblywoman Mila Jasey, current chair of the Assembly Higher Education Committee, is also retiring. The Summer TAG Awards grant has been signed into law allowing HESAA to award summer tuition aid grants.

# 5. FY2024 Council Operating Budget Overview- Preliminary Discussion

Fichtner reviewed an overview of the proposed FY2024 Operating Budget. The budget needs to be transmitted to the full Council by May 12, 2023 for vote at the June 12, 2023 Council meeting. A note of significance is that the TIAA Cref suspense account has been completely expended as of April 7, 2023. We have been putting funds into reserves over these last five years to account for this. Fichtner presented assessment scenarios of a 2 % increase in FY2024. Fichtner reviewed the office occupancy expenses that will be split in thirds between the Council, Workforce Consortium, and Pathways operating budgets. Fichtner reviewed the personnel who are shared amongst the three budgets as well.

By motion of Mike Gorman, and seconded by Barbara Gaba, the Executive Committee approved a 3% Assessment increase for the FY2024 Council Operating Budget.

The Executive Committee members all agreed to moving their May meeting up one week for a final review and vote on the FY2024 Council budget.

#### 4. Update: State Budget and Legislation

Fichtner reported that the Senate and Assembly Budget hearings concluded today. The hearings were well attended by our presidents. There is still a fair amount of work to be done. The Legislative Action Center is working, 500 people have sent approximately 11,000 emails to members of the legislature. Fichtner reported that we do have sponsors in both houses introducing resolutions for the \$20 million increase in operating aid to Community Colleges, specifically Senator Andrew Zwicker and Assemblywoman Linda Carter.

#### 5. Proposed Community College awards to be presented on June 12, 2023
